

Network Leaderboard Terms and Conditions

These terms and conditions (the “**Terms**”) govern the provision of the Lucky Rush network leaderboard infrastructure and related services (the “**Promotion**”) by PT SERVICES (DELAWARE) LLC (“**Playtech**”) to the participating licensee (“**You**” or the “**Licensee**”).

These Terms are supplemental to the Network Agreement and/or the Software License and Services Agreement (as applicable, the “License Agreement”) between Playtech, or any member of Playtech’s Group (as defined below), and the Licensee. In the event of any conflict or inconsistency between these Terms and the License Agreement, these Terms shall prevail with respect to the subject matter hereof.

The Promotion consists of a series of network leaderboards made available by participating Licensees to their end users, utilising Playtech’s network leaderboard technology and an overall prize fund of USD 800,000 fully funded by Playtech. Playtech acts solely as the network promotion supplier and is not a party to the contractual relationship between the Licensee and its end users participating in the Promotion.

1. General Terms & Conditions

1. This Promotion is operated and made available to players by each participating Licensee. Playtech provides the network leaderboard technology, operational support, and prize funding in its capacity as promotion supplier.
2. Promotion Duration: 05 June 2026 00:00 EDT to 23 July 2026 23:59 EDT for a total of 49 days.
3. The prize pool will be available to be won by the players of any opted in **Licensee**.
4. The **Promotion** consists of 7 network leaderboards, with dates listed in the table below.
5. The total prize fund for the **Promotion** is 800,000 USD in bonus funds.
6. The Leaderboards will pay out the following amounts:

8. Suggested Bonus Terms:
 - Bonus funds awarded through this **Promotion**:
 - Are non-withdrawable and must be used within Playtech slots games.
 - Suggested: 7 days to claim, 30 days to play. (Expiry period may be applied by licensee as required).
 - Will be used before cash funds for gameplay.
 - Will not be forfeited if the player withdraws their cash balance.
 - Any winnings generated from the use of these bonus funds will be credited as withdrawable cash.
9. **Playtech** will make available to **Licensees** a list of their winners and rank within 3 days of the end of each leaderboard Promotion.
10. **Licensees** who have Playtech bonus integration will have their prizes paid upon completion of the leaderboard.

11. **Licensees** who do not have bonus integration will be responsible for the payment of prizes to their players.

 - h. Do not alter any supplied **Playtech** marketing materials without express written authorisation from Playtech which shall be provided on a case-to-case basis.
 - i. Utilise the components of the dedicated network promotion promo pack across all platforms to maintain brand consistency.

3. Leaderboard Promotion

1. To take part in the **Promotion**, the player must open a participating game and "Join" a network leaderboard.
2. The player must join each network leaderboard individually. Opting into one leaderboard will not automatically gain entry to other leaderboards in the **Promotion**.
3. A minimum bet of \$0.20 is required. Bets below this amount will be excluded from the **Promotion**.
4. After joining each leaderboard, the player will be able to play up to 10,000 spins that will count for points earning purposes.
5. If a player leaves a leaderboard and rejoins, they will lose their earned points total and will not be allowed any extra spins towards the Promotion.
6. Results for each leaderboard will be available to players approximately 15 minutes after the leaderboard finishes.
7. Leaderboard positions are updated approximately every 5 minutes. During this time, player rankings may temporarily differ across participating sites. Final leaderboard standings will be determined based on the last synchronisation at the end of the Promotion Duration
8. Each leaderboard will accumulate all points earned by the player during the Promotion Duration. The player's final points total will reflect the sum of all points earned.

11. The maximum number of points that can be awarded for any single spin or feature outcome is ten thousand (10,000) points.
12. For the purposes of this Promotion, "Feature Buy" means a paid in-game purchase that grants entry to a feature round. Where a Feature Buy is used, the full purchase cost is treated as a single bet for calculating the win-to-bet multiplier and awarding points. 15. Eligible games may vary by Licensee. Certain Licensees may make additional exclusive titles available under their own terms.
16. Participation by Licensees and/or players is permitted only to the extent allowed under applicable laws and regulations in the relevant jurisdiction. Playtech may, without liability, exclude or restrict participation of any Licensee and/or player at any time where required by applicable law, regulation, or instruction of a competent regulatory authority.
17. Subject to Playtech's prior written approval (in its capacity as promotion supplier), Licensees may substitute the games above only where a branded version of the same game is available as a replacement.
18. Should **You** require us to exclude a group of players from the **Promotion**, **You** will communicate this to **Playtech** along with details of how to identify these players prior to 11 May 2026 23:59 EDT.

6. Exclusions and Cancellation

- Only players located in Pennsylvania, New Jersey, Michigan, and West Virginia, USA, are eligible to participate.
- In the event a player wins a prize and subsequently self excludes or similarly restricts their account, the **Licensee** must still pay the player unless there is a regulatory or other reason why this cannot be done.

8. Security Measures: Individual access to network leaderboard management interface with specific permissions required. Obfuscating of player data coming from different licensees. Opting-in for the implementation of the network leaderboard.
9. Cross-Border Transfer: As Playtech operates globally, data may be transferred across international borders and in such cases, will ensure contractual safeguards are in place.
10. Rights of Data Subjects: Individuals have the right to access, rectify, and erase their data. Players will be able to make requests to utilise their rights under applicable laws, via the Data Controller. Playtech will support the Licensees in their obligations to ensure the rights are enacted.

8 Additional Terms:
