

# Network Leaderboard Terms and Conditions

Terms & Conditions (the “**Terms**”) for the Lucky Rush Leaderboards (the “**Promotion**”) between Playtech Software Limited (“**Playtech**”), and the licensee (“**You**” or the “**Licensee**”). These Terms are supplemental to the Network Agreement and/or the Software License and Services Agreement (as applicable, “**License Agreement**”), between Playtech, or any company in Playtech’s Group (as defined below), and You. In the event of any conflict or inconsistency between these Terms and the License Agreement, these Terms shall prevail with respect to the subject matter hereof.

The **Promotion** by Playtech is a series of network leaderboards that will link multiple Playtech Licensees together to play for an estimated 5,000,000 EUR prize fund.

## 1. General Terms & Conditions

1. This **Promotion** is operated by **Playtech**.
2. Promotion Duration: 06 March 2026 00:00 CET to 17 January 2027 23:59 CET for a total of 318 days.
3. The prize pool will be available to be won by the players of any opted in **Licensee**.
4. Licensees may opt into the Promotion prior to launch or at any time during the Promotion Duration, subject to the configuration timelines set out in Section 2 (Licensee Opt-In Process).
5. The **Promotion** consists of 45 network leaderboards, with dates listed in the table below.
6. The total prize fund for the **Promotion** is an estimated amount of 5,000,000 EUR in cash.
7. The Leaderboards will pay out the following amounts:

8. The amounts are estimated and may be more, or less, depending on currency conversions, as well as numbers of players participating in the Promotion.
9. Participating players will be eligible for fixed cash amounts as detailed in the prize tables below.
10. Winnings from this **Promotion** will have no wagering requirements and can be withdrawn immediately upon crediting.
11. **Playtech** will make available to **Licensees** a list of their winners and rank within 3 days of the end of each leaderboard Promotion.
12. **Licensees** who have Playtech bonus integration will have their prizes paid upon completion of the leaderboard.
13. **Licensees** who do not have bonus integration will be responsible for the payment of prizes to their players. The total value of the winnings funded by Playtech and awarded to the Licensee's players during each calendar month will be aggregated and applied as a credit to the Licensee's invoice issued in the following month. Any credit amount that exceeds the value of that invoice will be carried forward to subsequent invoices. Only Leaderboards that have fully completed within the relevant calendar month will be included in that month's credit calculation, and any Leaderboard that spans two calendar months will be allocated to the month in which the Leaderboard ends.

## 2. Licensee Opt in Process

1. If a Licensee wishes to participate in the Programme, they must notify their designated Playtech Account Manager accordingly. Licensees may opt in prior to the initial launch date of 06 March 2026 or at any time thereafter.
2. For Licensees opting in after launch, the Licensee must specify the weekly leaderboard cycle from which they wish to begin participation. Inclusion in the selected week is subject to operational feasibility, with Playtech requiring a minimum of two (2) weeks' notice and up to a maximum of four (4) weeks to enable configuration and onboarding. Playtech will confirm the effective start week in writing.
3. A request to opt-in from the Licensee does not guarantee entry into the **Promotion**, and **Licensees** may be denied entry based on regulations, capacity or other reasons as seen fit by Playtech.

4. **Playtech** requires **You** to guarantee a promotional score of no less than 8 (eight) for the **Promotion Duration** with points awarded as below:
  - a. Place a minimum of 1 (one) **Promotion** banner on the main casino site and promotions tab, accessible via desktop and mobile, from 06 March 2026 00:00 CET to 17 January 2027 23:59 CET (1 point per banner. Maximum of 3 points)
  - b. Premium placement on the casino home screen for 1 (one) included game within the first 4 (four) positions throughout the **Promotion Duration** (2 points per game. Maximum of 8 points)
  - c. A dedicated promotion page for the **Promotion** for the **Promotion Duration** in the promotional area of the **Licensee** web site. (1 point)
  - d. Minimum of 1 (one) dedicated CRM campaign via email, SMS or push notification to be sent to players for each stage of the leaderboard, 5 (five) in total to be sent while the **Promotion** is running. (1 point per CRM campaign. Maximum 5 points)
  - e. Advertising across social media channels (1 point)
  - f. Promotional banner placed on sportsbook if applicable (2 points)
  - g. Discuss and finalise any alternative promotional arrangements with your **Playtech** account manager.
  - h. Do not alter any supplied **Playtech** marketing materials without express written authorisation from Playtech which shall be provided on a case-to-case basis.
  - i. Utilise the components of the dedicated network promotion promo pack across all platforms to maintain brand consistency.

### 3. Leaderboard Promotion

1. To take part in the **Promotion**, the player must open a participating game and “Join” a network leaderboard.
2. The player must join each network leaderboard individually. Opting into one leaderboard will not automatically gain entry to other leaderboards in the **Promotion**.
3. Playtech will not define a minimum bet for a player to take part in the **Promotion**.
4. After joining each Leaderboard, the player will be able to play 10,000 spins that will count for points earning purposes.
5. If a player leaves a leaderboard and rejoins, they will lose their earned points total and will not be allowed any extra spins towards the promotion.
6. Results for each Leaderboard will be available to players approximately 15 minutes after the leaderboard finishes.
7. Each leaderboard will take the players top 25 individual scores as the players’ final points total. Any other points earned will be disregarded.
8. In the event of a tie-on points, the player who has the most remaining events available will be considered the higher-ranking player. If players are tied on both points and events, then whoever achieved their score first will be considered the higher-ranking player.
9. Points will be awarded based on the win-to-bet ratio of each individual spin, multiplied by 100.
  - Player stakes £2 and wins £100
    - $(100 / 2) \times 100 = 5,000$  Points
  - Player stakes €10 and wins €15
    - $(15 / 10) \times 100 = 150$  Points
10. The maximum number of points that can be awarded for any single spin or feature outcome is ten thousand (10,000) points.
11. For the purposes of this Promotion, “Feature Buy” means a paid in-game purchase that grants entry to a feature round. Where a Feature Buy is used, the full purchase cost is treated as a single bet for calculating the win-to-bet multiplier and awarding points. All winnings generated from the purchased feature round(s) count toward the player’s points, and the Per-Spin Points Cap applies. Where a Feature is triggered organically (not purchased), only the triggering bet amount will be used.
12. To be eligible for a ranked prize, a player must have accumulated at least one hundred (100) points and placed within the prize-winning positions of the relevant leaderboard. For the

avoidance of doubt, achievement of 100 points does not guarantee a prize; the player must also place within the paid ranks.

13. Only game rounds played on the games listed below shall be eligible for point accumulation ('Eligible Games'). Playtech may, at its discretion, add further titles to the Eligible Games list as new releases become available. The most up-to-date list of Eligible Games will be maintained on the Lucky Rush microsite, and Licensees acknowledge that such list may be updated periodically.
14. Eligible Games consist of (i) a fixed list of Core Games which shall remain unchanged for the entire Promotion Duration, and (ii) a Rotating Games list that may be updated periodically by Playtech for operational or seasonal reasons. Updates to the Rotating Games list will only apply to future leaderboard cycles and will not affect any ongoing or completed cycles. The most up-to-date list of Eligible Games will be made available by Playtech through the dedicated network promotion materials. Playtech will notify Licensees in advance of any updates to the Rotating Games list, where practicable.

15. At **Playtech's** discretion, **Licensees** may substitute the games above only if they have a branded version of the same game as a replacement.
16. Should **You** require us to exclude a group of players from the **Promotion**, **You** will communicate this to **Playtech** along with details of how to identify these players prior to 16 February 2026.
17. It is hereby clarified that points may only be issued via the Terms in the network leaderboard in this Promotion. Any points found to have been issued from any other source will be invalidated and may lead to the **Licensee's** disqualification from the Promotion at **Playtech's** sole discretion which would lead to no refund of prizes by **Playtech**, and the **Licensees** will be liable for any prizes paid to players.

#### 4. Key Dates & Payouts

1. The **Promotion** will run from 6th March 2026 to 17<sup>th</sup> January 2027 and consists of forty-five (45) consecutive leaderboard cycles.

## 6. Exclusions and Cancellation

- Players in the following countries may not participate:
  - Afghanistan, Antarctica, Belarus, Bosnia and Herzegovina, Brazil, Central African Republic, China, Cuba, Cyprus, Czech Republic, Democratic Republic of the Congo, Denmark, Ethiopia, Guinea, Guinea-Bissau, Haiti, Holy City (Vatican), Hong Kong, India, Indonesia, Iran, Iraq, Israel, Italy, Japan, Latvia, Lebanon, Libya, Lithuania, Macao, Malaysia, Mali, Myanmar, Nicaragua, North Korea, Palestine, Portugal, Russia, Serbia,

Sierra Leone, Singapore, Somalia, South Sudan, Spain, Sudan, Sweden, Switzerland, Syria, Turkey, Ukraine, United States of America, Venezuela, Yemen, Zimbabwe

2. In the event a player wins a prize and subsequently self excludes or similarly restricts their account, the **Licensee** must still pay the player unless there is a regulatory or other reason why this cannot be done.
3. Playtech reserves the right to disqualify players if it reasonably suspects that collusion or other abusive strategies takes place. Players must comply with the eligibility requirements of these Terms. Playtech reserves the right to withhold any prize won by anyone whom Playtech is aware or has reasonable grounds to believe is ineligible.
4. Playtech reserves the right to amend or cancel this Promotion or amend these Terms: (i) without notice if the change or cancellation is a result of any legal or regulatory change; or (ii) for any other valid reason by giving You notice in advance of the change, provided that such change or amendment shall not have a detrimental effect on players that have already participated in the leaderboard pursuant to this Promotion.

## 7. Data Protection

1. Data Controller: Licensee
2. Data Processor: Playtech
3. Purpose of Processing: Scores for each player will be held on a central server to facilitate a network leaderboard, aligned to the contracted services.

5. Legal Basis: Contractual obligation to allow Playtech to ensure the provision of the services requested by Data controller.
6. Data In Scope: Data listed in table above is in scope.
7. Data Retention: Playtech will retain the data for the duration specified in our agreements with each licensee, in reference to their player data.
8. Security Measures: Individual access to network leaderboard management interface with specific permissions required. Obfuscating of player data coming from different licensees. Opting-in for the implementation of the network leaderboard.
9. Cross-Border Transfer: As Playtech operates globally, data may be transferred across international borders and in such cases, will ensure contractual safeguards are in place.
10. Rights of Data Subjects: Individuals have the right to access, rectify, and erase their data. Players will be able to make requests to utilise their rights under applicable laws, via the Data Controller. Playtech will support the Licensees in their obligations to ensure the rights are enacted.

## 8 Additional Terms:

1. These Terms are governed by and shall be construed in accordance with the laws of England and You submit to the exclusive jurisdiction of the Courts of London, England, unless otherwise agreed between the parties under the License Agreement.
2. The non-mandatory design package in this Promotion is for illustrative purposes only and provided to all Licensees by way of a non-exhaustive example (“**Playtech Suggestions**”). For the avoidance of doubt, the timings of any network tournaments may not be changed. Playtech does not warrant that the Promotion is compliant with the laws of any jurisdiction, and it is Licensees’ responsibility to ensure that the actual specifications of the Promotion shall be determined by it in compliance with all applicable laws.
3.
